LBF President Hon. John C. Davidson (Ret.) is traveling throughout the state with the 2024-25 LBF Pop Up Tour to educate everyone about the LBF and Civil Legal Aid. This year the Pop Up Tour focuses on Children's Legal Services.

**The Justice Bus is the collaboration of the LBF and LLL** to deliver civil legal aid services to those most in need. The bus travels to civil legal resource deserts, communities that are more than a 45-minute drive away from a civil legal resource, and that have limited access to legal services. More than 600,000 income eligible Louisianans (34%) live in these civil legal resource deserts where meaningful legal assistance is simply out of reach. Amanda Brown, Lagniappe Law Lab Founder and Executive Director will speak at the Northshore and Greater Orleans Pop Ups.

**Children and Families Justice Clinic**, a new partnership of the LBF and Loyola University New Orleans, College of Law, recently launched to train the next generation of lawyers how to understand and meet the needs of court involved families. Loyola University College of Law Dean Madeline Landrieu will speak about the importance of this initiative at the Greater Orleans Pop Up at Urban South Brewery.
