The bus travels to civil legal resource deserts, communities that are more than a 45-minute drive away from a civil legal resource, and that have limited access to legal services. More than 600,000 income eligible Louisianans (34%) live in these civil legal resource deserts where meaningful legal assistance is simply out of reach. Amanda Brown, Lagniappe Law Lab Founder and Executive Director will speak at the Northshore and Greater Orleans Pop Ups.
