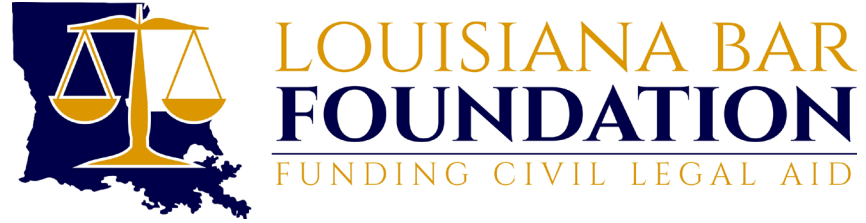

**Civil Legal Aid** is free legal assistance provided to help people facing non-criminal, civil legal challenges.

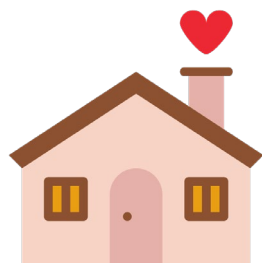
Access to an attorney is not a fundamental right in civil matters.

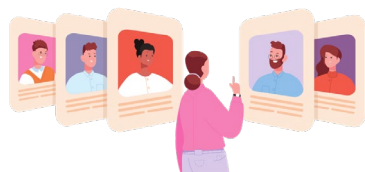

# Why We Help



**40%** of Louisiana's population earn incomes below **200%** of the Federal Poverty Level.

Louisiana has more than **1.7 million** people who are potentially eligible for free civil legal aid.

We currently have **1** civil legal aid attorney for every **11,230** eligible people.

# Eligibility for Services

General guide for income eligibility for civil legal aid services.

Residents may be eligible for civil legal aid services if their family income is below 125% or 200% of federal poverty guidelines.

Asset limits may also apply. Limits may be higher for senior citizens aged 60+. This is a chart for general income guidance.

## By the Numbers: How Louisiana Ranks Nationally

### Poverty

The overall poverty rate in Louisiana was 18.6% in 2022, down from 19.6% in 2021, the second highest in the nation. This means 829,565 Louisianans lived at or below the federal poverty line last year.

**3<sup>rd</sup>**

### Child Poverty

The share of children living in poverty in Louisiana remained high at 24.4%, down from 26.7% in 2021. This leaves 255,159 children - 1 in 4 - growing up in poverty in Louisiana.

### Income

Household median income remained among the nation's lowest, falling slightly to \$55,416 in 2022 from \$56,301 in 2021, continuing a downward trend since pre-pandemic 2019 income levels.

### Income Inequality

Income inequality remained high in Louisiana. That's largely due to the high concentration of poverty - not high accumulation of wealth.

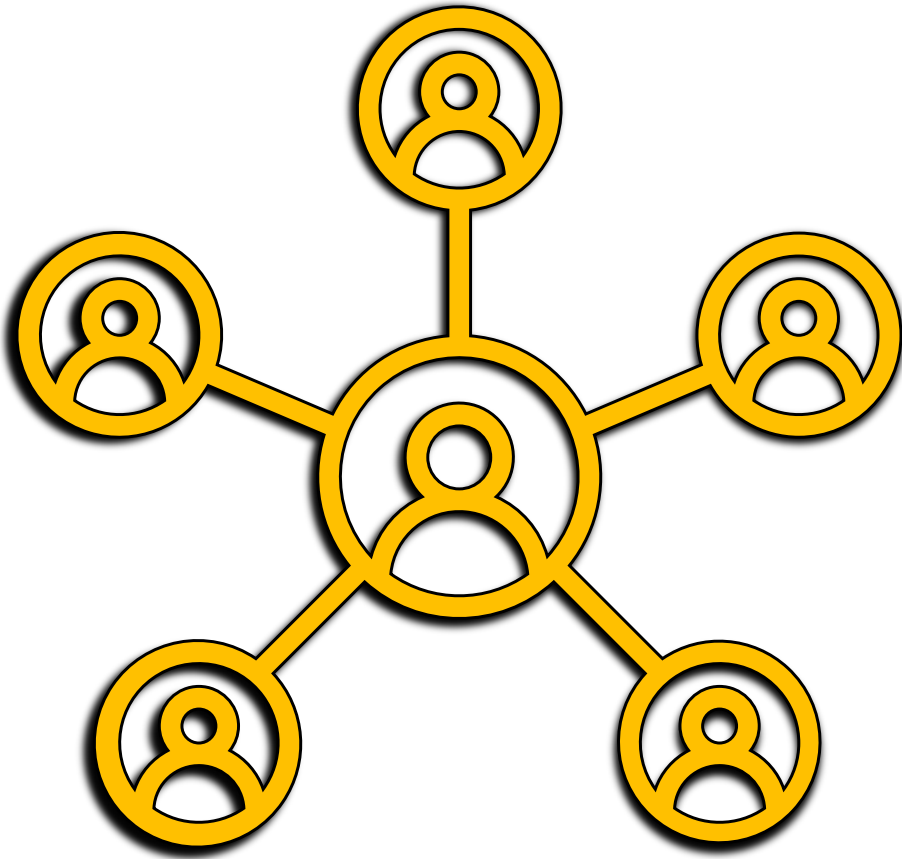

# How We Help



## Louisiana's Civil Legal Aid Network

- The responsibility for meeting the civil legal needs of Louisiana's poor falls primarily on a network of nonprofit, civil legal aid organizations.
- LBF's robust network of well-established partnerships with more than 70 grantees across the state's 64 parishes is leading community-driven efforts to help hundreds of thousands of Louisiana residents gain access to the legal system.
- In 2024-25 fiscal year we awarded \$14.6 million in grants.
- Since 1989 the LBF has provided more than **\$133.3 million** for civil justice initiatives.



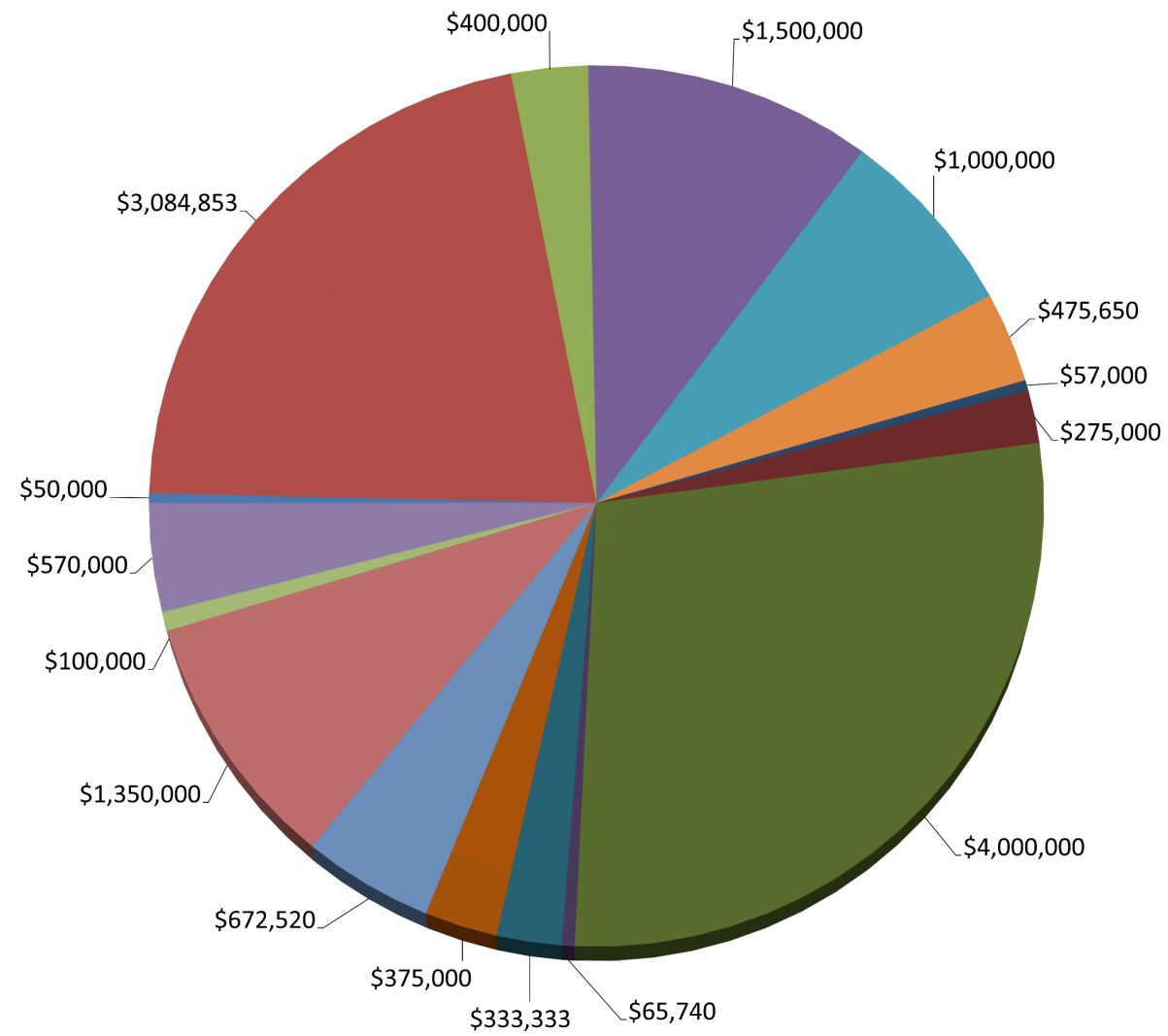

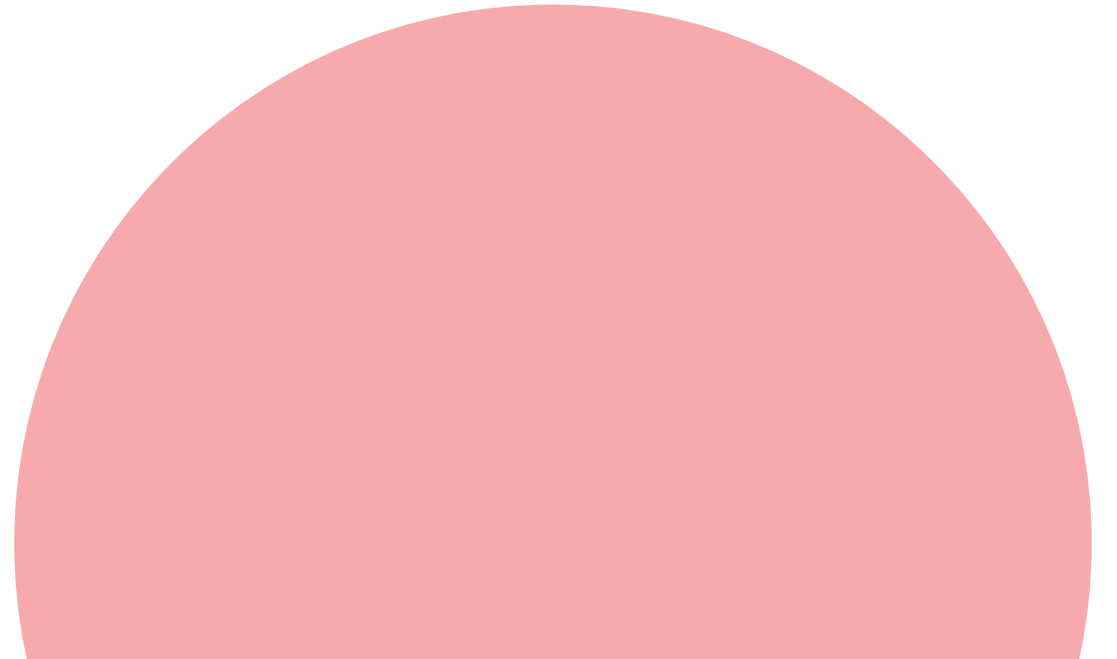

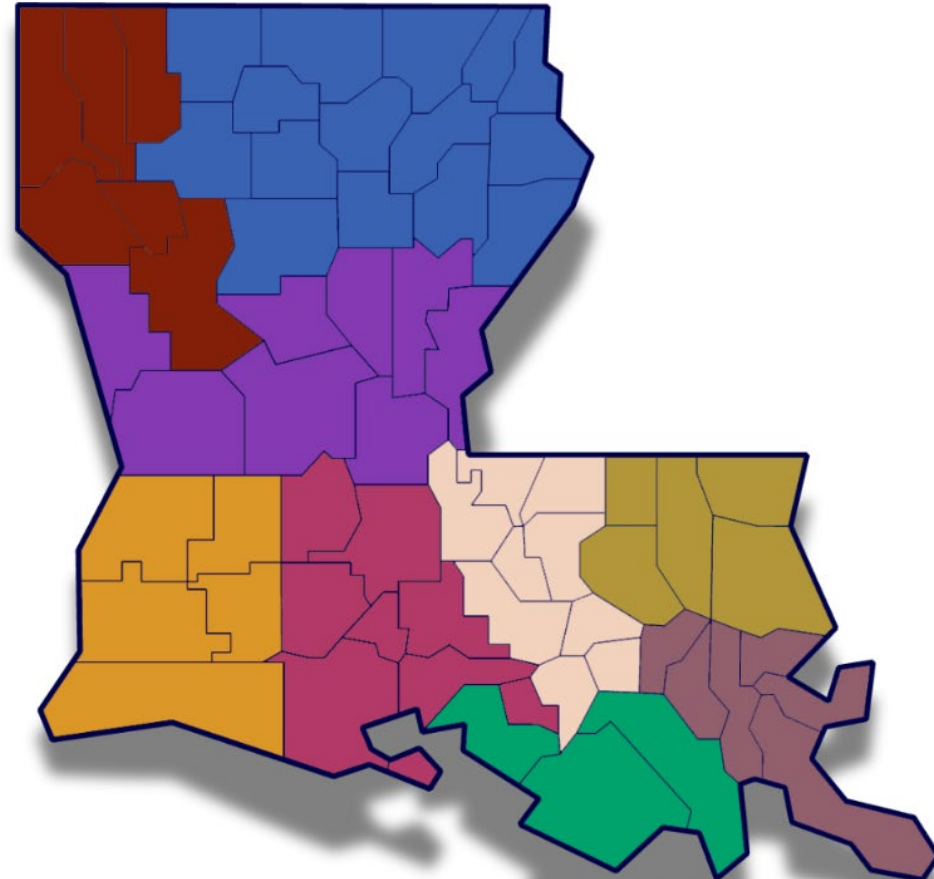

# Jock Scott Community Partnership Panel Grants

The nine CPPs act as regional chapters of the Foundation identifying needs in their community and fund efforts to address those needs. This year, each panel awards up to \$52,850 in Jock Scott Community Partnership Panel Grants.

The grants are awarded to 501(c)(3) organizations in need of assistance to initiate or expand an activity that meets at least 1 of the following 3 criteria:

- 1) Provides direct legal services to the poor;
- 2) Provides law-related education; and/or
- 3) Provides for the administration of justice.

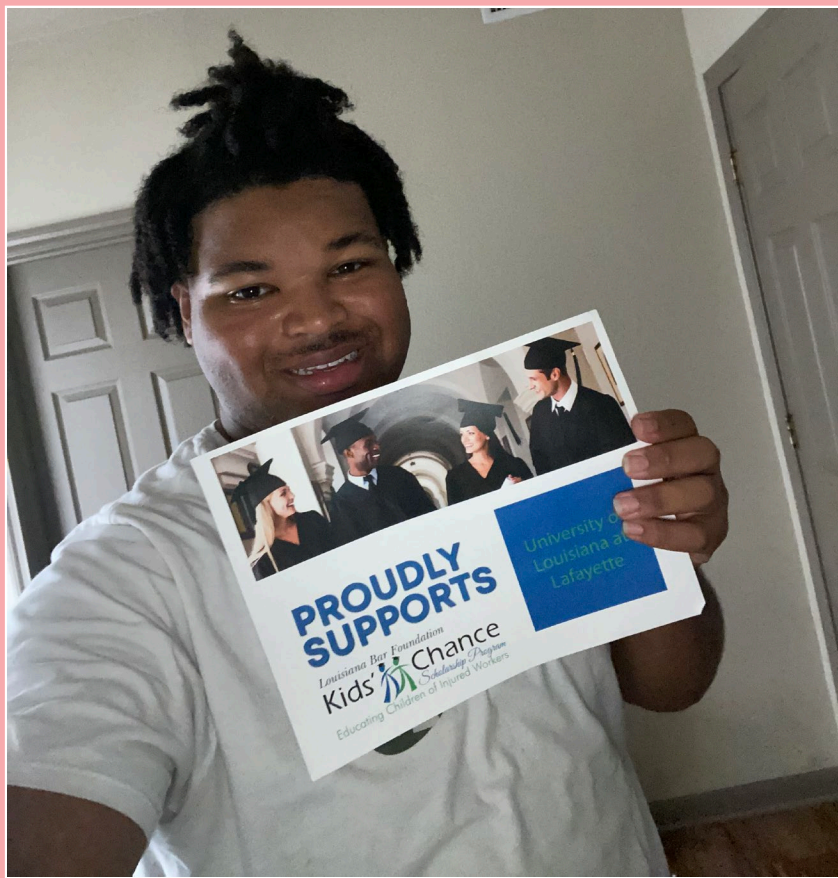

Other Initiatives



The **Louisiana Bar Foundation Kids' Chance Scholarship Program** is the state chapter of a national organization that awards scholarships to the children of Louisiana workers who have been killed or permanently and totally disabled in an accident compensable under a state or federal Workers' Compensation Act or law.

These work accidents often result in difficult challenges for the family as they struggle to overcome the financial burden of these losses.

Often a child's dream of going to college is crushed because of unexpected income loss and/or the necessity to forfeit an education for work to financially support other family members.

**Since 2004, the program has awarded 337 scholarships totaling \$863,100.**

**Governor Jeff Landry proclaimed November 18-22, 2024 Louisiana Bar Foundation Kids' Chance Awareness Week in Louisiana.**



## Children and Families Justice Clinic

Loyola Law School and LBF have partnered to create the Children and Families Justice Clinic.

Student practitioners in the clinic will play a key role in developing trauma-informed training opportunities for lawyers, judges, court personnel, community partners, and court-involved mental health professionals.

### Law Schools Outreach

We are working directly with law schools to engage and educate law students; establish clinical programs that focus on civil legal aid and create a pipeline for aspiring public interest attorneys.

We partner with the LSBA in many areas including our access to justice efforts to improve the delivery of legal representation across the state.

## Louisiana Supreme Court

We thank the Louisiana Supreme Court for their continued commitment to ensure access to equal and fair representation of the poor in Louisiana.

## Louisiana Workers' Compensation Corporation

LWCC is our longest standing partner and fundraiser for the Kids' Chance Scholarship Program.

## State of Louisiana

Through a Cooperative Endeavor Agreement with the **Office of the Louisiana State Treasurer**, LBF receives funding for legal representation of children in child protection cases and adult civil legal aid. LBF awards grants through agreements with ALSC and SLLS in collaboration with the Louisiana Department of Child and Family Services and the Louisiana Supreme Court.

Through a Cooperative Endeavor Agreement with the **Louisiana Housing Corporation**, LBF receives funding for direct representation of impoverished citizens in matters of title clearing (homeowner foreclosure), foreclosure prevention, mediation, and mortgage loan modifications., education, counseling. LBF has agreements with ALS, SLLS, Louisiana Appleseed and Lagniappe Law Lab to provide statewide services.

# IOLTA PROGRAM



LBF administers the **Interest on Lawyers Trust Accounts Program (IOLTA)** on behalf of the Louisiana Supreme Court. Finance staff works with financial institutions on eligibility, compliance, and rates.

Our **Prime Partners** are institutions that go above and beyond eligibility requirements to foster the IOLTA Program. These institutions pay 60% of the Fed Funds Target Rate and are committed to ensuring the success of the IOLTA program and increased funding for legal aid.

Our **statewide Prime Partner** banks are Chase, First Horizon, Hancock Whitney, and Regions. A list of **local Prime Partner** banks are on the LBF website.

The Judicial Fellowship level is for a full-time federal or state judge, magistrate, commissioner, administrative law judge, or hearing officer.

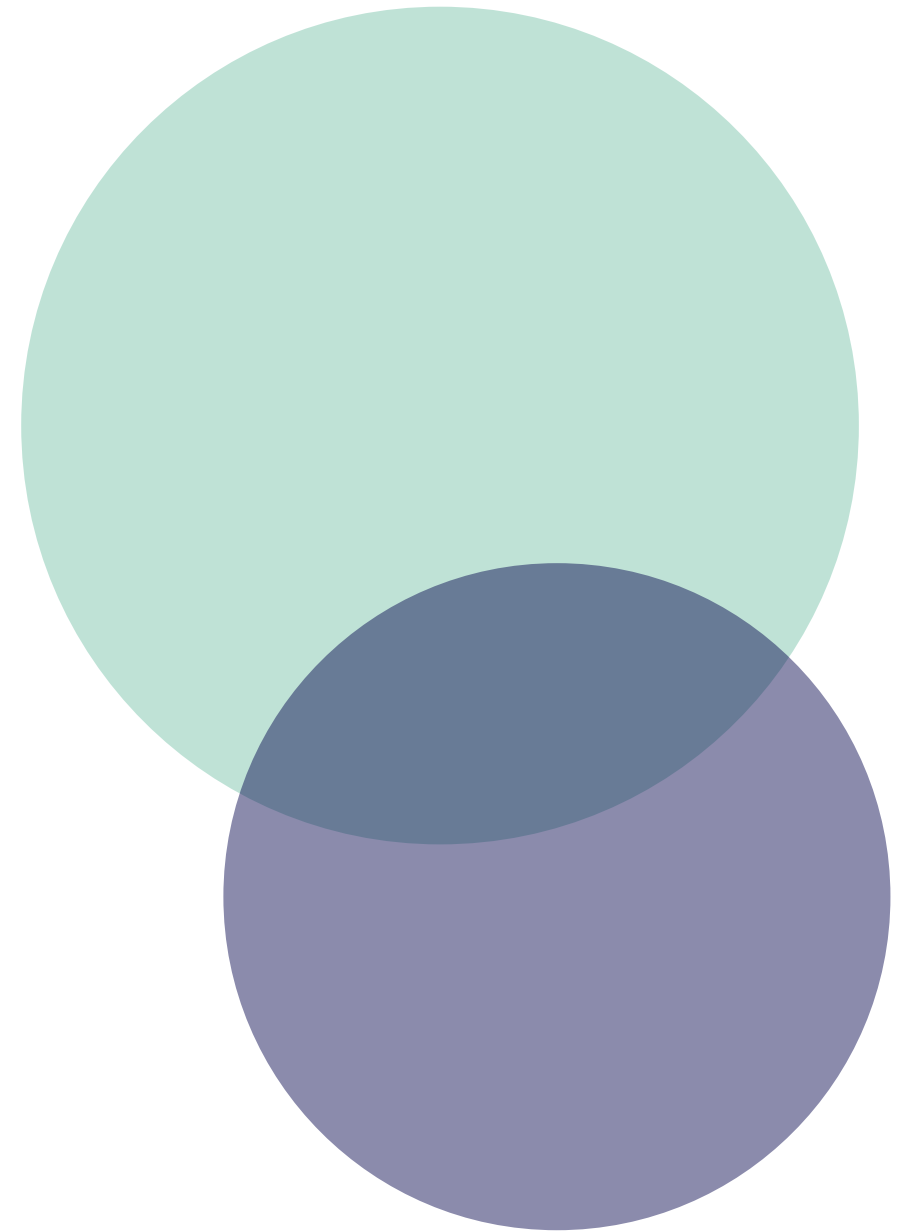

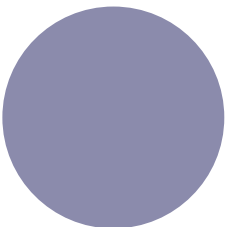
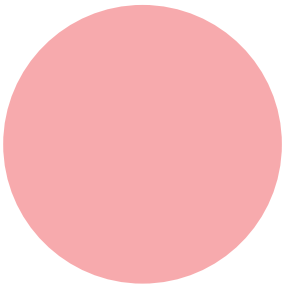
